**Summary Annual Report for**

This is a summary of the annual report for UNIFIED FIRE AUTHORITY HEALTH & WELFARE TRUST, EIN 75-3134967, Plan Number 501, for the period July 1, 2020 to June 30, 2021. The annual report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

**Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was \$5,570,305 as of June 30, 2021, compared to \$4,532,674 as of July 1, 2020. During the plan year the plan experienced a change in its net assets of \$1,037,631. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$1,277,609 which included employer contributions of \$190,093, employee contributions of \$0, other contributions of \$0, gain/loss of \$0 from the sale of assets, and earnings from investments of \$1,087,516.

Total plan expenses were \$239,978. These expenses included \$39,155 in administrative expenses and \$200,823 in benefits paid to participants and beneficiaries, and \$0 in other expenses.
